It goes without saying that the continuing board members, namely Samantha Owen, our deputy chair, James Townsend, our board secretary, Serena Grant, Lucy Clarkson-Fletcher, teacher at our school and ex-officio member all continue to make an outstanding contribution to the governance of the school as of course does Bronwyn Hope who as Principal of our school is also a board member and with whom, speaking for the board, it has been a pleasure to work with.

This past year has been very active from a School and governance perspective.

Since our last AGM, reviews and audits including; child safety, student learning and assessment, the school improvement plan, the quality improvement plan and the policies that govern our school have all been carried out. The Board has also conducted qualitative in-depth interviews with a sample from each stakeholder group at our school as well as in depth interviews being offered to departing staff and board members. The amalgam of all the above in addition to reporting, information and analysis that forms part of regular board and committee meetings have all provided the school leadership and the board with valuable insights into how the school is operating.

The Board as a whole, takes great comfort in the synthesis and combination of its analysis of the school, and is happy and satisfied with how the school is operating across all areas that encompass its governance role. Beehive continues to do an excellent job of providing an authentic Montessori Education within a safe and inclusive environment not only for the children but also for our outstanding staff and parents. The school community has proved adaptable and resilient throughout the pandemic.

Development of our infrastructure has also recommenced, with building work for our Piccoli programme, an ablutions block for Middle Primary, and a Master Plan for the northern end of the school which includes demolition of our original school buildings, Adolescent Program facilities and a much expanded and improved playground.

As to this coming year, we look forward to welcoming and embedding our new board members, and I have no doubt that Beehive will continue providing excellence in Montessori education, nurturing independence so that our children find their place in, and contribute to, a better world.

We will work to ensure a secure future for the school providing educational excellence within the context of a holistically appropriate educational environment with our strong sense of community citizenship, underpinned by our core values of respect, compassion, curiosity, responsibility and individuality.
